1 Based on the Second Stipulation Amending Order Preliminarily Approving Settlement
2 and Providing Notice Dated June 22, 2015, and good cause appearing, IT IS HEREBY
3 ORDERED AS FOLLOWS:

4 1. Paragraph 5 of the Order Preliminarily Approving Settlement and Providing
5 Notice entered by the Court on June 22, 2015, with respect to the above matter (“Preliminary
6 Approval Order”), as amended, is hereby further amended to provide that the Fairness


